There are no refunds on treatment or consultations.** Phone sessions can not be booked until this paperwork is signed and returned to our office. Dr. Yuen reserves the right to record the audio from all phone sessions. Any information shared with him during the session is fully confidential and will not be reused or released. Information is recorded for quality control and for personal reference by Dr. Yuen. Patients are responsible for additional time used and any additional time used will be charged accordingly.

**The below text is for your own information and does not need to be returned to us.**

We need to have the attached form signed and returned to us prior to booking a time. Please fill it out, sign, and return it to us at your convenience. You can fax or mail the form back to us. Our fax number is 818-347-4124. Our mailing address is CEM 22647 Ventura Blvd. #379 Woodland Hills, CA 91364. Once we receive the signed form back in the office, we will email to offer you a time. Once you have confirmed your time, we provide the direct phone number for you to reach Dr. Yuen. Dr. Yuen is usually booked about 2 weeks in advance.

The first phone session with Dr. Yuen is **25 minutes** and the cost is **\$310**. After your initial session, within the following six months, you can do follow-up session(s) with him. The follow-up session is either 25 minutes at \$310 or you can do a short session which is half the time and the cost is \$150. The follow-up session(s) may or may not be necessary since everyone's issues are so different. Dr. Yuen will give you the amount of time that you booked with him. **While on the phone with Dr. Yuen, if you would like to extend your session to a longer amount of time than you originally booked, you will be charged accordingly.**

If you would like to make a **prioritized list** of the issues you would like Dr. Yuen to work on, please do so. You can have this information in front of you at the time of the session or you can email the information **at least 24 hours prior to [drklist@yahoo.com](mailto:drklist@yahoo.com)**. If you would like to email your list, please put your **name and the date** of your session in the **subject line** of the email. Please send by noon the day before your session pacific time.

Try to keep the list **brief**, and simply **list** what your issues are, how the issues affect you personally on a daily basis, and how they make you feel emotionally: this is the best information Dr. Yuen is looking for that will allow him to make the appropriate corrections for you. Actions and time of the day that the issue occurs is also good information to provide for Dr. Yuen. You do not need to include lengthy information about previous diagnosis, long stories, or others' opinions on what is causing the issues.

Please understand that the more issues you list, the more “watered down” your individual corrections will be as Dr. Yuen will attempt to address your entire list of issues. So you will need to decide the number of issues you include on your list based on this idea: if you want very **deep corrections** to be made to only a few issues, only include **5-10 issues** on your list. Alternatively, if you prefer Dr. Yuen to make corrections for a lengthy list of issues (**more than 10 issues**), he will spend less time on each individual issue, making more **superficial corrections** to each issue, as this is the only way to ensure he will be able to get through a lengthy list. Some example for acceptable list formats are as follows:

- 1) Leg pain/back pain when sitting/standing that makes me feel frustrated/helpless.
- 2) Difficulty sleeping (I wake up at 3:00AM) that makes me tired the rest of the day.
- 3) Issues with finances and personal relationships that cause me fears about my future.

Please keep in mind that, although the results of corrections can be instantaneous, everyone reacts differently to the corrections. Thus, it may take up to approximately 48 hours for the full benefits of the corrections to set in. This is referred to as a settling period for the body and the mind to get on the same page after corrections are made.

Also, there is a section on the form that mentions **homeopathic remedies**. In regards to Dr. Yuen’s homeopathic remedies, he may or may not recommend homeopathic remedies to you to assist in supporting the specific corrections he made. He will only recommend remedies if they will benefit you and the specific issues he addresses for you. If Dr. Yuen recommends any remedies, we will contact you first to find out if you would like to receive them prior to charging/shipping the products.
